SCHEDULE A; outlines the insurance requirements.

SCHEDULE A

INSURANCE

Unless greater insurance limits are required in an appendix to this Contract, a Confirmation or other document properly executed by authorized representatives of the parties, or by law, Carrier agrees to procure and maintain at its own expense the following insurance in at least the following amounts during the term of this Contract:

- a. Cargo Insurance: \$100,000 USD per shipment.
- b. Automobile Liability Insurance: \$1 million (USD) Combined Single Limit for bodily injury and property damage;
- c. Worker's compensation: as required by law;
- d. General liability – limited to \$1 million per occurrence, \$3 million aggregate (USD) for bodily injury and property damage;
- e. Must be Additionally Insured- Truckload carrier (7 car and above)
- f. Any insurance coverage, endorsements, or requirements required by any governmental body for the type of transportation and related services specified in any appendix;

All insurance required by this Agreement must be written by an insurance company having a Best's rating of B++ or better and must be authorized to do business in the state(s) or province(s) in which Carrier performs the transportation and related services. Carrier's insurance shall be primary and required to respond and pay prior to any other available coverage. Carrier shall furnish written evidence of its insurance coverage to Carrier Management upon request and shall advise Carrier Management of any change in its insurance coverage thirty (30) days prior to the effective date of such change. Carrier further agrees to procure and maintain any and all insurance required by federal, state, Provincial, Territorial, Municipal, local, or to the extent applicable, international laws. Carrier shall cause the required insurance to be procured naming United Road Logistics, LLC. as "Certificate Holder" on any Public Liability, General Liability, and/or Automobile liability, Cargo liability policies. Upon execution of this Agreement, Carrier shall furnish to Carrier Management written certificates obtained from each insurance carrier showing that the required insurance has been procured.

BROKER/CONTRACTOR AGREEMENT

THIS AGREEMENT is made and entered into this _____ day of _____, 20__ by and between, on one hand, United Road Logistics, L.L.C., Inc., AAAAutolog Corporation, and URS Midwest Inc. located at 10701 Middlebelt Road, Romulus, Michigan 48174 and _____ (hereinafter referred to as "CARRIER"), located at _____.

WHEREAS United Road, AAA and URS are all brokers organized and existing under the laws of the State of Michigan and are engaged in the business of vehicle logistics from new vehicle manufacturers, assembly plants, ports, rail distribution centers, auctions, marshaling yards, terminal distribution centers, common dealerships and/or private locations. For purposes of this Agreement, United Road, AAA and URS will hereafter be collectively referred to herein as "Broker."; and

WHEREAS BROKER from time to time engages independent carriers to transport vehicles from its clientele in order to meet and fulfill its motor vehicle logistics obligations and does so under Department of Transportation Broker Operating Authority Number MC526599 issued in accordance with 49 C.F.R. §371; and

WHEREAS CARRIER expressly warrants and represents to BROKER that it is a contract carrier operating under the Department of Transportation operating authority and CARRIER expressly warrants and represents to BROKER that its Department of Transportation Operating Authority Number _____ has never been suspended, revoked and/or expired; and

WHEREAS CARRIER expressly warrants and represents to BROKER that it has all of the required _____
